1. ALL PERMANENT AND TEMPORARY LIGHTING IS TO BE INSPECTED AND APPROVED BY THE CHIEF ELECTRICAL INSPECTOR PRIOR TO OPERATION OF THE USE.
2. A GENERAL LAYOUT OF THE SITE MAY BE REQUIRED SHOWING THE LOCATION OF STRUCTURES, TABLES, CHAIRS, BOOTHS, ETC. NO STRUCTURE MAY BE ERECTED WITHOUT FIRST OBTAINING A BUILDING PERMIT AND AN INSPECTION(S).

5. SITE IS TO BE CLEARED OF ALL MERCHANDISE AT THE CLOSE OF DAY \_\_\_\_\_, AND BE CLEARED OF ALL TEMPORARY STRUCTURES WITHIN \_\_\_\_\_ DAYS AFTER CLOSING.
6. ADEQUATE PUBLIC PARKING FOR THE EXCLUSIVE USE OF THIS FACILITY INCLUDING A STABILIZED DRIVE AS REQUIRED IS TO BE PROVIDED AND MAINTAINED. IT IS THE RESPONSIBILITY OF THE OPERATORS TO GUIDE TRAFFIC TO THESE AREAS AND TO KEEP PATRONS FROM PARKING ALONG THE SHOULDERS OF THE ROAD IN THE VICINITY OF THE ACTIVITY UNLESS WAIVED BY THE VILLAGE.
7. ANY SPECIAL DETAIL FOR TRAFFIC CONTROL OR OTHER PURPOSES REQUIRED BY THE GRAYSLAKE POLICE DEPARTMENT SHALL BE PROVIDED AT THE EXPENSE OF THE PERMITTEE.
8. THE PERMITTEE AGREES TO INDEMNIFY AND HOLD THE VILLAGE AND ITS OFFICERS, OFFICIALS, EMPLOYEES, AND AGENTS HARMLESS FROM AND AGAINST ANY AND ALL CLAIMS OR LIABILITIES WHATSOEVER THAT MAY BE ASSERTED BY ANY PERSON (INCLUDING THE PERMITTEE AND ITS OFFICERS, OFFICIALS, EMPLOYEES, AGENTS, AND ASSIGNS) ARISING FROM, RELATED TO, OR CONNECTED WITH, EITHER DIRECTLY OR INDIRECTLY, THIS TEMPORARY USE PERMIT OR THE PERMITTED ACTIVITIES OR ANY ACTS OR OMISSIONS OF ANY PERSON OCCURRING AT THE EVENTS COVERED BY THE TEMPORARY USE PERMIT, PROVIDED THAT SAID CLAIMS OR LIABILITIES ARE NOT THE RESULT OF ANY GROSSLY NEGLIGENT OR WILLFUL AND WANTON ACT OR OMISSION OF THE VILLAGE OR ITS OFFICERS, OFFICIALS, EMPLOYEES, OR AGENTS.
9. THE PERMITTEE WILL DEMONSTRATE THAT ADEQUATE WASTE DISPOSAL FACILITIES WILL BE AVAILABLE. THIS SHALL INCLUDE TRASH CANS AND SANITARY FACILITIES.
10. ANY FOOD PREPARATION ASSOCIATED WITH THIS EVENT SHALL MEET THE REQUIREMENTS OF THE LAKE COUNTY HEALTH DEPARTMENT AND OBTAIN ALL REQUIRED PERMITS AND LICENSES THEREFROM.
11. THE VILLAGE OF GRAYSLAKE HAS THE RIGHT TO REQUIRE ADDITIONAL CONDITIONS AND RESTRICTIONS AS THEY PERTAIN TO THE EVENT OR ACTIVITY, INCLUDING THE CONDITIONS ATTACHED HERETO IN ADDENDUM NO(S)\_\_\_\_\_.
12. THIS PERMIT SHALL BE REVOCABLE UPON A DETERMINATION BY THE BUILDING AND CODE COMPLIANCE MANAGER THAT THE TEMPORARY USE OR ITS CONTINUATION WILL ENDANGER THE PUBLIC HEALTH OR SAFETY OF THE PARTICIPANTS OR ATTENDEES OF THE TEMPORARY USE OR THE RESIDENTS OF GRAYSLAKE.
13. THE VILLAGE OF GRAYSLAKE RESERVES THE RIGHT TO REQUIRE THAT THE PERMITTEE POST A PERFORMANCE SECURITY DEPOSIT OF NOT LESS THAN \$150.00 TO PROTECT AGAINST DAMAGE TO PUBLIC PROPERTY, LITTER, OR OTHER VIOLATIONS OF VILLAGE CODES OR ORDINANCES OR PERMIT TERMS. THE VILLAGE MANAGER MAY FROM TIME-TO-TIME ESTABLISH A SCHEDULE OF REQUIRED DEPOSITS BASED ON THE SIZE, LOCATION, TIME, AND ACTIVITIES TO OCCUR IN CONNECTION WITH A TEMPORARY USE PERMIT.

ANY VIOLATION OF ANY CONDITIONS OR PROVISIONS TO THIS PERMIT SHALL BE A CLAUSE FOR THE REVOCATION OF THE TEMPORARY USE PERMIT AND MAY SUBJECT THE PERMITTEE TO FINES. IN ADDITION, SUCH VIOLATIONS SHALL BAR THE PERMITTEE FROM RECEIVING ADDITIONAL TEMPORARY USE PERMITS FOR SUCH USE FOR A PERIOD OF TWELVE (12) MONTHS, UNLESS OTHERWISE EXPRESSLY APPROVED BY THE GRAYSLAKE BOARD OF TRUSTEES.

PERMITTEE IN ACCEPTING THIS TEMPORARY USE PERMIT, UNCONDITIONALLY AGREES AND CONSENTS TO THE TERMS, PROVISIONS, AND CONDITIONS SET FORTH HEREIN.
